### Have your say

Southwark Council is holding a consultation exercise to receive residents' and key stakeholders' comments regarding proposals to improve the streetscape and appearance of Westmoreland Road.

### Background

Westmoreland Road is a home to a major regeneration scheme currently underway in Faraday Ward and Southwark Council is looking to improve the appearance and streetscape of the Westmoreland Road shopping parade. Changes proposed are mostly aesthetic with new lighting provision, new street trees, benches, inset parking bays and wider footways.

### Funding

Westmoreland Road Scheme is being funded from Section 106 contribution made by the Aylesbury Estate Regeneration Project.

### What are the proposed changes?

It is proposed that the following measures are implemented to improve the streetscape of Westmoreland Road:

- Raised table at the junction with Red Lion Row to reduce vehicle speeds, shorten pedestrian crossing distance and improve road safety for all users
- Introduction of inset resident parking and pay and display bays.
- Provision of new quality street trees in buildouts to provide greening. These have been located in buildouts to guarantee sufficient clearance from buildings to ensure trees grow to maturity.
- Proposed cycle stands to support sustainable transport
- A new improved lighting provision
- Benches are proposed within the widened footways to provide rest points for all users
- Dedicated loading bay to assist local businesses. This results in a loss of two resident and/or pay and display parking bays. Provision of loading facilities supports Council's objective of helping local businesses and improving safety for all road users.
- The existing road is being reduced in width to 4.8m to facilitate the widened footways. This is an acceptable road width for two-way roads.
